Daughters & and Dads Football

Terms of Participation

I am the parent or guardian of the daughter signing up for the program with me or have been granted permission from their parent or guardian for them to participate in the program with me. In this document, "daughter" refers to the child participating in the program, regardless of their status or lack thereof as the biological daughter of the adult participating in the program.

Data Privacy Agreement

I understand that the personal information provided will be used solely for the purposes of program administration, communication, and evaluation. This information will be kept confidential and stored securely.

Indemnity and Release Declaration

In consideration of participating, and allowing my daughter to participate, in the program, I agree both on behalf of my daughter and in my own right, with Football West and The University of Newcastle (UON) as follows:

- a. I acknowledge that participation in the program involves inherent risks, hazards and dangers including the risk of injury and risks associated with heat and exposure to the sun.
- b. To the full extent permitted by law, and excluding any claims directly caused by Football West or The University of Newcastle's negligence or wilful misconduct:
 - i. I agree, to absolve, indemnify and keep indemnified Football West and The University of Newcastle and their directors, officers, employees, volunteers, sponsors and agents involved in the program against all costs, losses or damages however caused arising from, or in relation to, my and my daughters' participation in the program.
 - ii. I agree, to waive, release and forever discharge Football West and The University of Newcastle and their directors, officers, employees, volunteers, sponsors and agents involved in the program from all claims and/or causes of action that I or my daughter have or may have arising from any injury, loss or damage of any kind suffered by myself or my daughter including personal injury, illness or death and/or loss or damage to any property (in so far as this does not breach the provisions of the Trade Practices Act) arising either directly or indirectly out of the participants' participation in the program.
 - iii. I authorise registered program facilitators and coordinators to arrange medical or hospital treatment for myself and my daughter (including, without limitation, ambulance transportation) if I am not available to do so and I indemnify Football West and The University of Newcastle for all associated costs.
 - I agree not to bring any claim, demand, action or proceeding against Football
 West or The University of Newcastle (which shall include its directors,
 employees, agents and volunteers) for any damage, loss or injury whatsoever



- that me or a child may suffer from participation in the program, except to the extent directly caused by Football West and/or The University of Newcastle's negligence or wilful misconduct.
- v. I acknowledge there is an unquantifiable risk of transmission of viral illness including COVID-19 associated with participation in the program, and I have considered that risk and my and my child's personal circumstances, including any vulnerability that my child or I may have or that of persons whom my child or I will be in close contact with following my participation in the program. I acknowledge that, for a small number of people, COVID-19 has very serious health consequences.
- vi. Limitation: I agree that the total aggregate liability of The University of Newcastle (including that of its directors, employees, agents and volunteers) to myself and my daughter for loss or damage arising in connection with the program, whether under contract, tort (including negligence), under statute or otherwise act law or in equity, shall be limited to \$10,000.

Code of Behaviour

I agree to adhere, and ensure that my daughter adheres, to the program's code of conduct, which includes:

- Treating others with respect, kindness, and consideration.
- Engaging positively and participating actively in all activities.
- Following instructions from program staff.
- Prioritizing safety and respecting personal boundaries.
- Taking care of program property and facilities.
- Reporting any suspicious or concerning behaviour by other participants to program staff immediately.

I understand that failure to comply with this Code of Conduct may result in myself and my daughter being removed from the program.

Child Safety and Conduct Agreement

By registering for the program, I agree to the following:

- 1. Legal Eligibility: I confirm that I am legally permitted to be around children and have not been convicted of any offenses related to child abuse, neglect, or any other crime that would disqualify me from participating in a program involving children.
- 2. Respectful Behaviour: I commit to acting in a respectful, kind, and considerate manner towards all children and participants in the program. I understand that any form of harassment, bullying, discrimination, or inappropriate behaviour is strictly prohibited and may result in my immediate removal from the program.



3. Duty to Report: I acknowledge that if I observe or become aware of any behaviour that may endanger the safety or well-being of any child, I have a responsibility to report it immediately to the program staff.
